

Terms and Conditions

Effective Date: 12th of September 2024

These Terms and Conditions ("Agreement") govern the use of the services ("Service") provided by **Attila Tokolics ev.** ("we", "us", "our", "ingr.io"). By accessing or using our Service, you ("User", "you", "your") agree to be bound by this Agreement. If you do not agree to these terms, you may not use the Service.

1. Service Overview

- **Informal Resolution:** Before initiating any legal action, you agree to attempt to resolve any dispute with us informally by contacting us.
- **Arbitration:** Any dispute arising out of or in connection with this Agreement shall be resolved through binding arbitration in accordance with the rules of Veszprém District Court, Hungary. You waive your right to participate in a class action lawsuit or class-wide arbitration.

- **Entire Agreement:** This Agreement constitutes the entire agreement between you and Attila Tokolics ev. regarding the use of the Service.
